## Your Message

- Tell your story.
- · Be respectful and professional.
- Keep it about the kids.

Our representatives are elected to work for us. They need as much information as possible to make good decisions about public education – and you happen to be the expert.

- If you decide to call the hotline, it only takes a minute to leave a message for all three of our legislators.
- The staff person on the other end of the phone is there to record your opinion. They will not mock you or argue with you.
- Start with an introduction. "Hi my name is \_\_\_\_\_ and I'm a constituent of Rep./Sen. \_\_\_\_ calling about (your concern) and I don't/do need a reply."
- Have a script. Say what you are comfortable saying. Remember, you are just calling to be counted.
- Expect their response. Most of the time they will just tell you they will pass on your concern.
- Thank the staffer and hang up.

## **Talking Points**

We support and ask our legislators to consider . . .

- reversing the levy swap (state property taxes raised, local levies cut & capped) (Consider restructuring our state tax system if property taxes are a concern.)
- restoring much-needed levy flexibility gives local voters the ability to invest in education programs that meet the unique needs of our students beyond state-funded education. Restoring levy flexibility will reduce financial uncertainty and allow districts to provide consistent ongoing support for students.
- returning to the staff mix factor (rather than an average) for funding certificated positions so staff costs and funding align and to provide greater certainty and continuity in staff hiring.
- increasing funding for the state funded staff allocation (prototypical school) model for nurses, psychologists, social workers, counselors, and school resource officers. (ex: Current state allocation is one nurse for our entire district.)
- fully funding Initiative 1351 to reduce 4-12 class size, and add counselors, nurses, paras, others. We appreciate the K-3 portion of this initiative has been funded but the other needs it was designed to address remain. Local levies enable school districts to provide support for student needs the state does not provide.
- changing our 6% regionalization factor funding to a fixed allocation model, rather than the current plan for this funding to be eliminated.
- making sure that if SEBB (School Employees Benefits Board insurance) is implemented, there is no budget impact to school districts.
